**As an assistant district attorney, I prosecuted misdemeanor and felony criminal cases in the Municipal, Common Pleas, and Family Courts of Philadelphia and researched and wrote memoranda of law and appellate briefs. I specialized in the prosecution of crimes of domestic violence and provided assistance to the victims of these crimes.**

**While an associate at Zarwin & Baum, my practice involved general civil litigation with primary emphasis in the areas of insurance and criminal defense and plaintiff's personal injury. I managed my own case load and had full responsibility for all phases of litigation process.**

**As a pro-bono attorney for the Support Center for Child advocates I was appointed by the court and served as guardian ad litem for several children in the dependency courts of Philadelphia's Family Courts.**

**As special advisor to the Sheriff, Director of the Integrity and Accountability Office, Director of the Special Investigations and Fraud Unit, and consultant to the Philadelphia School District, I regularly researched, analyzed, and applied applicable principles of federal, state, and municipal laws, including federal and state constitutional issues, labor law issues, and local and state regulations pertaining to a variety of issues.**

- 6) State briefly why you are seeking the Democratic nomination to be a judge in Philadelphia, and what qualities you believe you possess that would serve you especially well if you were elected to the Court.

**Much of my professional career and civic involvement has been dedicated to improving the quality of life and the quality of justice for the citizens of Philadelphia. I want to be a judge because I believe that judges can have a positive impact on people's lives and the quality of life in our community.**

**If elected, I will be fully committed to treating ALL people with respect and dignity and insuring fair and equal treatment. Rather than accept the status quo, I will also work hard to find solutions to problems and inefficiencies in our court system to better serve the needs of the citizens, attorneys, law enforcement and city agencies, and the numerous other stakeholders who work within or come in contact with our judicial system.**

**My background is atypical from the other judicial candidates, however, my career path has, in many fundamental ways, prepared me for this position. For the reasons described below, my record clearly demonstrates that I have the skills, character, and temperament necessary to do this important and sensitive job.**

**I have been a lawyer in good standing for twenty-one years, and have had five solid years of litigation experience. I am familiar with and comfortable in the courtroom. While I have not recently engaged in litigation practice, my varied experiences illustrate the fact that I have the ability to quickly grasp and master new subjects. For this reason, I have no doubt that prior to assuming judicial duties; I would gain expertise in the policies and procedures necessary to effectively fulfill the duties of a Common Pleas Court Judge.**

**Understanding the technical rules of evidence and procedure are only part what makes a great judge. Other less tangible qualities such as the sincere desire to seek the truth, the make a positive difference, impartiality, common sense, the deep desire to seek the truth and make appropriate, reasonable rational decisions are equally, if not more important.**

**My entire career has essentially involved seeking the truth and applying that knowledge to effectuate positive change. As a prosecutor, litigator, legal advisor, investigative producer, independent police auditor, and Director of Special Investigations and Fraud for the City of Philadelphia's financial watchdog agency, I have established a reputation for thoroughness, fairness, and integrity and have engendered the trust, cooperation and respect of people with whom I have worked, even in adversarial circumstances.**

**In my various roles, I have been able to instigate positive changes despite dealing with issues that were challenging, controversial, and complex. I attribute my successes to the fact that I approach each subject and issue impartially and with an open mind. I do not make conclusions or recommendations until I have carefully and thoroughly considered all perspectives on an issue, obtained and reviewed the facts and evidence, and then applied the pertinent standards. I treat people fairly and**

**with respect and I am an active and engaged listener.**

**My record has clearly demonstrated my attention to details, my ability to absorb and synthesize large amounts of information, and my excellent research, analytical, and writing skills**

**I will apply the same work ethics and diligence to the bench that I have shown in my entire career.**

**I believe that biases, prejudices, and stereotypes exist throughout our society, including the judicial system. I have dedicated my pro-bono activities to addressing these issues and problems. Please refer to Question #6 for how I propose to address biases in our judicial system.**

- 8) What are the most pressing needs of reform in our judicial system?

**The lack of comprehensive, effective, widely available, and easily accessible resources and services which are needed to address the complex needs of many individuals who are part of the criminal and family courts, such as mental health and drug and alcohol treatment programs and services, job training, among others. Probation and Parole officers maintain enormous and unreasonable caseloads that prohibit meaningful oversight. Case backlogs result in tremendous inconveniences for victims of crimes and result in many cases being discharged.**

- 9) For what organizations have you done pro-bono work?

**Anti-Defamation League** - Executive Board Member and former Chair of the Civil Rights and Education Committees of the Eastern Pennsylvania/Delaware region chapter of the ADL. The ADL is a national civil rights/human relations agency that combats all forms of racism, bigotry, and prejudice and works to insure fair and equal treatment for all people through educational, legislative, and advocacy initiatives.

**The Disciplinary Board of the Supreme Court of Pennsylvania** – I am a Hearing Committee Member in matters pertaining disciplinary actions against attorneys.

**The Support Center for Child Advocates** - Former Board member and pro-bono attorney for private non-profit agency that provides legal and social services to abused and neglected children in Philadelphia.

**LEADERSHIP, INC.** - Graduate of 2002 class. Participant in nine month program designed to enhance knowledge of critical civic issues, and to develop and enrich leadership skills.
