FELONY COMPLAINT

The undersigned is informed and believes that:

COUNT 1

On or between September 13, 2010 and April 15, 2011, in the County of Los Angeles, the crime of CONTINUOUS SEXUAL ABUSE, in violation of PENAL CODE SECTION 288.5(a), a Felony, was committed by PAUL CHAPEL, who did unlawfully engage in three and more acts of "substantial sexual conduct", as defined in Penal Code Section 1203.066(b), and three and more lewd and lascivious acts, as defined in Penal Code Section 288, with , a child under the age of 14 years, while the defendant resided with, and had recurring access to, the child.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."
