From authoritative information that I have received, it appears that:

— from June 25, 1997, you are illegitimately absent from St. John's Abbey, Collegeville, MN, since you did not return to the monastery when your indult of exclauration ceased to have effect;



— there has been, to date, no request sent to the Holy See for a dispensation from your religious vows or from the obligations of ecclesiastical celibacy;

— you have not received the permission of your legitimate superior, Fr. Timothy Kelly, Abbot of St. John's Abbey, to undertake Canon Law studies here at the Gregorian University, and such permission is required by the rules of this University (cf. *Ordo Anni Accademici 1997-1998*, p.30, n.5);

— the letter of recommendation of Fr. Daniel Ward, of April 17, 1997, is not authentic;

— when you registered in this Faculty, you declared that you are a layman, and such declaration does not correspond with the facts.

For the above reasons, I regret to inform you with this letter that you may no longer consider yourself registered in this Faculty of Canon Law, and thus must suspend immediately your attendance at the lectures.
