All reports of rape and sexual assault or attempts to commit such offenses and all conversations between police officers and victims of said offenses shall not be public reports and shall be maintained by the police departments in a manner which will assure their confidentiality.

Part of this request is being denied in accordance with M.G.L. Chapter 4, ss 7(26)(f). Exemption (f), applies to records that are:

investigatory materials necessarily compiled out of the public view by law enforcement or other investigatory officials the disclosure of which materials would probably so prejudice the possibility of effective law enforcement that such disclosure would not be in the public interest(s). ("provides an assurance of confidentiality to private citizens so that they will speak openly about matters under investigation. Any details in witness statements, which if released create a grave risk of directly or indirectly identifying a private citizen who volunteers as a witness are indefinitely exempt").

You have the right to appeal this decision to the Supervisor of Records, at the address below, within 90 days from your original request. The appeal must include your original request along with this response.
